The Construction Manager / Superintendent will be skillful delegators, adept at identifying crucial aspects of the project and prioritizing them— while staying on top off all other aspects of the project.

- Liaise with clients and team members to schedule day-to-day operation activities including project staffing levels
- Attend, chair and participate in onsite and offsite meetings with clients, owners, staff, contractors and other project stakeholders
